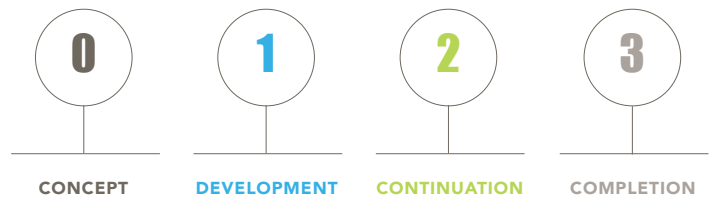

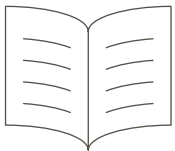

Sharing the Contract Accords with industry sponsors has led to streamlined and expedited negotiations. In one instance, the Contract Accords created a common language for our University's negotiations with a major company, a fellow UIDP member. We were able to quickly narrow the issues for discussion and it resulted in inking a five-year Master Agreement in a matter of weeks instead of the months such negotiations have historically required.

Accelerated Clinical Trial Agreement (ACTA)

A standardized agreement for industry-sponsored, multi-site studies, intended to reduce contracting delays. Developed in collaboration with Clinical and Translational Science Awards (CTSA) institutions.

Principled Partnerships

A quick guide to help interested parties develop clear understanding about the importance of U-I research partnerships and how potential financial conflicts are effectively addressed and managed.

Contract Accords

Practical guidance and detailed reference material to help parties understand and address challenges in negotiating collaborative research agreements. Publications cover 15 commonly recognized areas typically requiring additional time for resolution.

Researcher Guidebook

A practical handbook to help industrial and institutional researchers work together more effectively. The publication is intended for active researchers: Part 1 is dedicated to the Institutional Researcher; Part 2 is dedicated to the Industrial Researcher.

Corporate RFP

A guide that identifies strategic approaches to help companies develop requests for proposals (RFPs) that target academic institutions and experts who meet specific research and development and commercialization needs.

IP Quick Guide

A quick guide for non-IP professionals intended to build greater understanding of key elements of IP and how they might relate to negotiations.
